

## Application for the approval of donations by the Faculty for Medicine of the Technical University of Munich

### Important information:

Donated funds are, as all budgetary funds, subject to the provisions of budgetary law and must only be used for research and teaching and not for hospitality purposes. The principles of economic efficiency and thrift must be observed. This also applies to donations for which no donation receipt can be issued or is applied for as they are not subject to the conditions of tax relief. Even donations without a donation receipt can, on principle, not be used for hospitality purposes etc. unless this has been explicitly permitted by the donor (in writing). In cases of doubt, the financial department should be asked for advice in advance.

Sponsoring is governed by separate rules. Sponsoring means the offer of money or benefits in kind by companies who, by doing so, also want to pursue their own corporate goals of advertising and public relations. Contributions offered by the sponsor are considered donations only if the Technical University of Munich, represented by the Klinikum rechts der Isar, does not provide a service in return (e.g. by promoting the company or the products of the sponsor).
